Sl No.	Description
1	This licence shall be displayed in the prominent place in a prominent and conspicuous place in a part of the business premises open to the public and shall be produced for inspection as and when required by the Fertiliser Inspector, Licensing Officer or any other Officer authorized by the Government in this regard.
2	The holder of this licence shall scrupulously comply with the provisions of the Fertilizer (Control) Order 1985 and the notification issued there under for the time being in force, failing which the licence is liable to be cancelled.
3	The holder of this licence shall report from time to time to the Notified Authority and inform about change in the premise of sale depot and go downs attached to sale depot.
4	The holder of this licence shall file a separate Memorandum of Intimation (MOI) in Form A1 for each place when the business of selling fertilizer is intended to be carried on at more than one place.
5	Any change in the name of the Responsible Officer, named in the licence, shall forthwith be reported to the Licensing Officer.
6	The licensee shall not sell fertilizer for industrial use.
7	The holder of the State wholesale licence shall not transport any NPK fertilizer to other districts without prior permission from the concerned District Joint Directors of Agriculture.
8	The licensee shall maintain the record of sale of fertiliser in the form N as per Fertilizer(Control) Order 1985 and shall submit monthly return by 5th of every month to the Licensing Officer. The licensee shall also submit in time

	such other returns as may be prescribed by the Notified Authority.
9	All the registers and documents concerned to sale of Fertiliser, maintained by the Licensee shall be provided for scrutiny or any time to the Fertiliser Inspector, Licensing Officer or any other officer authorized by the Government.
10	The Licensee for hundred percent water soluble fertilisers shall comply fee as per Appendix -7 of Fertilizer (Control) Order 1985.
11	The Licensee who is an Importer shall intimate the Notified Authority as per FCO 1985 Clause35(4) with all details of Name of fertilizer, imported country, manufacturer, quantity imported, discharge port, designation of authorized person, about others within a period of 15 days.
12	The holder of this licence shall not offer for sale ,stock or exhibit for sale or distribute any fertilisers which is not of prescribed standard as per Fertilizer (Control) Order 1985.
13	The licence to sell a product is limited to the validity of the O form.
